Respectfully Showeth:

I, the above-named deponent do hereby solemnly affirm and declare as under: -

1. That the answering deponent has assumed the charge of Director Public Instructions (Secondary Education) Punjab, SAS Nagar on 04.07.2017. Hence this affidavit is being filed by the deponent.
2. That the present contempt petition is pending for 07.05.2018.
3. That the present contempt petition has arisen out of order dated 30.08.2011 passed in CWP No. 16021 of 2011. The operative part of order dated 30.08.2011 is hereby reproduced as under:

"The writ petition is accordingly disposed of in terms of the afore-stated decision of this Court in Baldev Raj Mittal and others' case (supra). Since the petitioners have approached this Court at a belated stage, it is directed that no arrears of pay shall be paid to them in the event of acceptance of their claim. However, if the respondents find that the claim of the petitioners is


4. That in compliance with order dated 30.08.2011 the claim of the petitioner was considered and pay of the petitioner was fixed in the pay scale of Rs. 110-250 and subsequent revised correspondent pay scales as per their service record. The District Education Officer (S.E.) Bathinda vide its letter No. E 1,2/() 2018/216-17 dated 02.05.2018 has informed the office of deponent via email that concerned D.D.O. of the petitioner Smt. Kamlesh Kumari, Hindi Mistress, Govt. High School, Dhade (Bathinda) has refixed the pay of the petitioner after granting her JST grade starting at Rs. 660/- and has prepared the bill No. 5 dated 02.05.2018 of arrears to the tune of Rs. 73,341/- and submitted it in the government treasury. After clearance the amount will be directly deposited into her bank account. Rest of the petitioners of COCP No. 1575 of 2015 have already been paid the arrears.
5. That as of now, in the humble understanding of the answering deponent, the order of this Hon'ble Court, from which the present COCP has arisen, stands complied with, However, some delay has occurred in implementation of order of this Hon'ble Court which neither was intentional nor deliberate and is a procedural one for which the answering respondent tenders

if any order of this Hon'ble Court may not have been understood in its true perspective, the deponent tenders an unconditional and unqualified apology for the same and is ready to take corrective measures as this Hon'ble Court may deem fit in the circumstances of the matter.

Keeping in view the submissions made above, it is therefore humbly prayed that present contempt petition may kindly be dismissed in the interest of justice and further prayed to disposed of the COCP and the deponent may kindly be discharged from rule of contempt in the interest of justice


