Sh. Rajesh Kumar Son of Sh. Devi Parsad, Street No.7, Gobind Colony, Near S.D. College, Barnala District Sangrur had filed Civil Writ Petition No. 1208 of 2002 in the Hon'ble Punjab and Haryana High Court. The Hon'ble Punjab and Haryana High Court vide its order dated 29-02-2012 directed to the respondents to consider the petitioners claim for selection as JBT Teacher in the reserve category and in case he makes it to the merit, then grant him notional service benefits. The relevant portion of the order is reproduced here under for the kind consideration of this Hon'ble Court.

"It is not a case where the petitioner acquired the eligibility after the cutoff date. The petitioner was already eligible as he was in possession of a "B" Grade Certificate issued in the old format. The change of format was a Ministerial action only, which too was complied with by him as soon as it was pointed out. In the peculiar facts and circumstances of this case, there appears to be no justification for not considering the petitioner eligible against the posts reserved for sports category.

The writ petition is, accordingly, allowed, Respondents No.1 and 2 are directed to reconsider the petitioners claim for selection as JBT Teacher in the reserved category of Sports personnel and in case he makes it to the merit, to grant him notional service benefits.

The necessary decision be taken within a period of 6 months from the date of receipt of certified copy of this order."

In compliance to the above said order the department vides its order no. E-2/2012-13/recruitment/416-19 dated 04-12-2012 issued appointment letter to the petitioner and he was appointed JBT Teacher w.e.f. 07-12-2001 on notional basis. Now the petitioner has filed COCP No. 3217 of 2013 vide which he has demanded promotion to the post of DPE on the basis of his notional date of appointment i.e. 07-12-2001, from the date his juniors have been promoted to the Master Cadre. I have gone through the relevant record pertaining to the claim of the petitioner. The department has already promoted

...T teachers appointed on dated 11-12-2001 to the post of DPE vide its order
No. 19/07-2008 E-2(4, 5, 6) dated 29-12-2009. Hence the junior to the
petitioner has already been promoted to the post of DPE.

1. Balbir Singh, Director Public Instruction (SE) Punjab, am of the
considered opinion that on the basis of facts and official record pertaining to
the promotion to the post of DPE, the claim of the petitioner is sustainable as
per rules. Accordingly his claim is accepted and he is promoted to the post of
DPE w.e.f. 29-12-2009 on notional basis. Station shall be allotted vide
separate order.

Order No. 20/19-2015 Estt-4(1), Estt-2(6)
Dated: 18-01-2016

The appointments for the posts of Head Masters/ Lecturers / Masters in various subjects were made pursuant to the advertisements issued by the Department of Education during in year 2006. The result of the selection was declared in November 2006 and appointments to most of the candidates were issued in December 2006. However, in certain cases particularly in cases of reserved categories, where vacancies had remained vacant during the first phase due to non availability of eligible candidates invited up to certain prescribed merit percentage, these vacant posts were filled up by inviting the eligible candidates by further lowering the prescribed merit percentage. In some cases, appointments have been issued at belated stage is complying with the directions of the Hon'ble High Court.

2. In such cases, the State Government Vide its instructions bearing No. 1/480/09-11:du2/6492, dated 20-11-2009 has already issued directions to grant benefits of pay fixation on notional basis and seniority by treating such candidates having been deemed to be appointed from the date juniors to such persons had been appointed.

3. In furtherance of the circular dated 20-11-2009 issued by the Government, vide letter No. 13/263-2014 Estt.-1(8), dated 19-12-2014 issued by this office, the respective Drawing and Disbursing Officers have been directed to extend at their own level the notional benefits in terms of directions dated 20-11-2009 in all similar cases after verifying the facts.

4. Since the letter dated 20-11-2009 has been issued in respect of Head Masters/ Lecturers only, the other category of teachers who have been appointed in same selection, have been approaching the Hon'ble High Court seeking the same notional benefits. In some of the cases, even the Hon'ble High Court has taken serious view regarding the fact that for seeking same benefits individuals are forced to approach the Hon'ble High Court.

5. In view of the above facts general directions are hereby issued to all Drawing and Disbursing Officers that benefits of notional pay fixation be given to all such Masters/Mistresses who were issued delayed appointment pursuant to various advertisements issued in year 2006. The pay in all such cases be re-fixed on notional basis from the date candidates of the same selection were appointed. For the purpose of seniority also such candidates shall be granted deemed date of appointment from the date candidates of the same selection were appointed.
